



GLEN LAKE KAYAK/CANOE RENTAL INFORMATION - 2017

Location: Glen Lake Launch, 290 Glen Lake Rd., Queensbury

Rental Season: May 1 – October 30, 2017 (26 weeks)

Rental Rates: Residents - \$125 Non-Residents - \$175

Rental Policies/Information:

- Rentals are for kayaks, canoes or SUP's (watercraft) only and storage slots CANNOT be sub-leased to others.
- Renters must provide their own cable and lock to secure all watercraft – renters assume all risks and are responsible for any damage to, or theft of, their own watercraft.
- Storage rack is for watercraft only – paddles and personal equipment CANNOT be stored. Renter is responsible for all equipment that is left on-site.
- ALL watercrafts must be removed from the rack on or before OCTOBER 30, 2017 – those left after Octoberth will be removed and the owner charged a \$50 service fee.
- The previous season renters are given first priority to re-rent for the next season. Rental agreements will be sent to previous renters on or around March 1st – all slots not rented by April 30th will be open and available for new renters beginning May 1st. If interest/demand necessitates, any new slots will be filled via a lottery system.
- Stored watercraft should be within the following size standards – 36" wide x 28" high x 18 ft. long and weigh less than approximately 80 lbs.
- Park's staff reserves the right to cut any lock and remove any watercraft, under the condition it deems necessary for the proper and safe function of the boat storage rack.
- There will be NO REFUNDS of a canoe/kayak rental fee. Prorated fee of \$100/\$150 will be given to any agreements taking place after September 1st.
- Renter agrees to use ONLY the storage slot that was assigned in the rental contract

- The storage slot will not be subleased or otherwise used for the storage of items not listed in the rental agreement. Rental agreement will be voided in this case and future use will be jeopardized.
- No refunds will be granted for any reason on rental agreements.
- This rental agreement can be terminated by the Queensbury Parks & Recreation if the rack is deemed unsafe, misused or damaged in any manner.
