- Storage rack is for watercraft only paddles and personal equipment CANNOT be stored. Renter is responsible for all equipment that is left on-site.
- ALL watercrafts must be removed from the rack on or before OCTOBER 30 those left after October 30th will be removed and the owner charged a \$50 service fee.
- The previous season renters are given first priority to re-rent for the next season. Rental agreements will be sent to previous renters on or around March 1st all slots not rented by April 30th will be open and available for new renters beginning May 1st. If interest/demand necessitates, any new slots will be filled via a lottery system.
- Stored watercraft should be within the following size standards 36" wide x 28" high x 18 ft. long and weigh less than approximately 80 lbs.
- Park's staff reserves the right to cut any lock and remove any watercraft, under the condition it deems necessary for the proper and safe function of the boat storage rack.
- There will be NO REFUNDS of a canoe/kayak rental fee. Prorated fee of \$100/\$150 will be given to any agreements taking place after September 1st.
